

CMHA Fee Refund Policy

It must be understood that some of each player's hockey fees are not subject for total reimbursement due to policies and conditions imposed by Hockey Manitoba. All registration and associated fees imposed by Carberry Minor Hockey Association (CMHA) are eligible for reimbursement consideration. The Carberry Minor Hockey Executive Committee (CMHEC) will be approving authority for all requests for reimbursement. Each request will be reviewed and consideration given to all mitigating circumstances for full or partial refund from the date of a season ending injury or the date of the request. The table below details how a refund will be determined. This will ensure that the process is transparent and will not compromise the ability of CMHA to meet its operational and financial obligations.

Injuries	An injury or illness that will cause the player(s) to miss a portion or an entire hockey season.	Once the injury and/or illness has been assessed and it is determined the player can no longer continue the hockey season, a formal request must be submitted to CMHA.	Sept: 100% of all fees Oct: 100% of Registration Fee Only Nov: 75% of Registration Fee Only Dec: 50% of Registration Fee Only Jan/Feb: 25% Registration Fee Only
Discipline	A player who continually violates the CMHA "Code of Conduct" and is detrimental to the team environment.	All attempts will be made to rectify the player's short comings through dispute resolution as per the CMHA Discipline Policy.	If there is sufficient cause for the dismissal of a player due to discipline related issues, there will be no refund.
Lack of Interest	A player has attempted the sport and/or no longer wishes to continue.	Only requests from first time players or players from the Squirts and Novice levels will be accepted. A formal refund request must be submitted to CMHA.	Sept: 100% of all fees Oct: 100% of Registration Fee Only Nov: 75% of Registration Fee Only Dec: 50% of Registration Fee Only Jan/Feb: 25% of Registration Fee Only
Re-Location	A player who can not continue to play due to relocation outside of the CMHA hockey district.	A formal refund request must be submitted to CMHA.	Sept: 100% of all fees Oct: 100% of Registration Fee Only Nov: 75% of Registration Fee Only Dec: 50% of Registration Fee Only Jan/Feb: 25% of Registration Fee Only
Personal Reason	A player does not wish to play for personal reasons.	A formal refund request must be submitted to CMHA.	These requests will be dealt with on a case by case basis. CMHA will determine if a refund is merited. Any refund granted will be as per percentages above.
Other	Any other reason not outlined above.	A formal refund request must be submitted to CMHA.	These requests will be dealt with on a case by case basis. CMHA will determine if a refund is merited. Any refund granted will be as per percentages above.
